The members of the committee were motivated to participate in workshop/short term trainings on sexual harassment conducted by various government agencies/ Department.

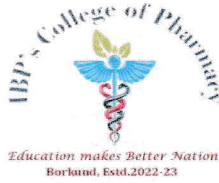
The roles and responsibilities of the faculty members were discussed.
